#### TERMS AND CONDITIONS FOR AFFILIATE PROGRAM

#### **AFFILIATE PROGRAM**

• The affiliates hereby agree and acknowledge to hold a business affiliation for the purpose of selling a school management application called 'Edutrack School app' and for any other purpose stated within this agreement.

#### **SCOPE**

• The affiliates hereby agree that the scope of work is the selling of the application on a commission based on the quantity sold.

#### **TERM**

• The agreement shall have a term of a year from the date first above written. Thereafter, the term may be renewed upon mutual written consent of the organization.

## **COMMISSION ON SUBSCRIPTION PACKAGE PLANS**

The affiliates hereby agree that the commission is N10,000 on the sale of each application when the client pays the first payment only
and a termly payment of N1,000 on each school referred which may be reviewed by the organization if/when necessary. This applies to
only subscription package plans.

#### COMMISSION ON ONE TIME ORGANIZATION HOSTED PACKAGE PLANS

• The affiliates hereby agree that the commission is 5% on the sale of each application when the client makes the payment only excluding the payment made on domain and hosting registration. **This applies to only one time company hosted plan.** 

#### COMMISSION ON ONE TIME SELF HOSTED PACKAGE PLANS

• The affiliates hereby agree that the commission is 5% on the sale of each application when the client makes the payment only excluding the payment made on domain and hosting registration. This applies to only one time self hosted plan.

#### OTHER TERMS AND CONDITIONS

- Every affiliate will have their own dashboard on the organization website to monitor their payment records, clients and other related details.
- Every affiliate is expected to fill the form on the website so that their details will be recorded on the website.
- Ensure you type in the correct information as this will be what the organization will work based on. Any issues arising from incorrect information will not be the liability of the organization. Commission payments will be paid ONLY into the accounts provided by the affiliate on our website.

- Referred customers must maintain an active service during any free trial and/or money-¬back guarantee periods applicable in order for the affiliate Reward to be considered earned.
